1 Call to order and welcome

District Director (DD) Glen Pearce called the meeting to order at 9.30 am and welcomed all present.

DD Glen Pearce stated that this meeting is now being recorded, for minute taking purposes only.

DD Glen Pearce explained the protocols for this online meeting, including those present in the room due to bandwidth issues. He explained that all votes will be cast using the voting platform and that once voting has been declared closed and the vote result announced, no further votes would be counted. He reminded members that anyone wishing to have their vote recorded should contact the Administration Manager or District Parliamentarian, either using the Zoom chat function or at the conclusion of the meeting. Club Officers can cast a maximum of two votes, District Officers can cast a maximum of three votes (their District Officer vote and up to two Club Officer votes).

A test vote was conducted.

The timer was Bailey Wood (online).

DD Glen Pearce explained the timing rules:

Those who wish to speak, must adhere to the following requirements:

- The mover of a motion has two (2) minutes with a one-minute right of reply.
- All other speakers (other than the mover of a motion) have two (2) minutes.
- The seconder of a motion has the same time limit as all other speakers but may reserve their right to speak at any time up until the mover's right of reply.
- The total debate time for any motion is twelve minutes. Timing for debate starts as soon as I ask for the first speaker. The timer timing the debate will let me know when time has elapsed.
- At 30 seconds remaining, the timer will display a red light. At the end of the elapsed time, our timer will start clapping and we will join him.

• The total debate time for any motion is twelve minutes. Timing for debate starts as soon as I ask for the first speaker. The timer timing the debate will let me know when time has elapsed.

DD Glen Pearce reminded members to start with their name and vote that they hold before commencing to speak.

DD Glen Pearce reminded members of the speaking rules for debates.

11.3 Confirmation of New Clubs into Areas

DD Glen Pearce reported that no new clubs have chartered since the District 72 Council Meeting held 13 May 2023.

12 **2024** Conference Update

DD Glen Pearce asked PQD Mary Jaksch to provide an update regarding our 2024 District Conference.

PQD Mary Jaksch explained that there had been no bids for the 2024 District Conference at the time of the Annual District Council Meeting on 13 May but that she was happy to announce that the District Executive Committee has approved Dunedin as the venue of the 2024 conference. She asked Conference Chair Craig McGregor to present the conference report.

Craig McGregor, 2024 Conference Chair: The 2024 District Conference will be held at the Otago Museum in Dunedin from 3 – 5 May 2024. The conference theme is 'A Journey through Time', reflecting both that we will be in the 100th year of Toastmasters and our location in a museum. The conference whakataukī is 'Kia whakatōmuri te haere whakamua' ('I walk backwards into the future with my eyes fixed on my past.') encapsulating how moving into the future builds on what has gone before.

We have confirmed Dr Ian Griffin, Director of the Otago Museum and a noted science communicator, as a keynote speaker.

Registration will open in early November. The early bird rate is \$140, available until 31 January.

Craig urged all Area Directors, Division Directors and Club Presidents and Vice-Presidents Education to start talking about the conference with their club members.

PQD Mary Jaksch moved that the report of the Dunedin 2024 Conference Committee be received.

DD Glen Pearce opened the report for discussion.

There was no discussion.

13 | Financial Reports

13.1 District Financial Report for the period 1 July 2022 to 30 June 2023

The Financial Report for the period 1 July 2022 to 30 June 2023 is on the website and details plus commentary can be found there.

FM Sheryl Ryan presented the District 72 Financial Report for the period 1 July 2022 to 30 June 2023 and highlighted the following points under Revenue & Expenditure:

- We made a deficit, with expenditure exceeding income by (\$7,318).
- The biggest overspends compared to budget were under Club Growth \$3,351, Conference \$2,308, Lodging \$2,266 and Travel \$2,130.

She also highlighted the following points under the Statement of Financial Position:

- Total assets \$55,633, made up mostly of the District Reserve and the cash left in the bank.
- Not much in the way of liabilities. (Most of the liabilities are outstanding cheques from ten or more years ago.)
- Net assets \$54,946.
- Biggest change in equity position is that Toastmasters International have reduced the District Reserve by \$27, 835 to be used for wider organizational purposes in accordance with Protocol 8.4 3B.

Sheryl also pointed out that Toastmasters International had told her on 14 September that she could now run the June reports.

FM Sheryl Ryan moved that that the Audited District Financial Report for period 1 July 2022 to 30 June 2023 be received.

Seconded: Terry Cave, Division G Director

DD Glen Pearce opened the Audited District Financial Report for the period 1 July 2022 to 30 June 2023 for discussion.

Svetlana Sabitova, VP-Education, MBIE Toastmasters asked what was the main contribution to the underspend on Education & Training.

FM Sheryl Ryan explained that some planned training had not occurred in order to fund the overspend in other areas.

Peter Simmonds, President, U-CAN-SPEAK asked why the spend on Club Growth was nearly twice the budgeted amount.

PQD Mary Jaksch explained that the overspend on Club Growth was due to it being cheaper to print the new Visitors Booklet in bulk, which will save costs in subsequent years.

Celina Templeman, VP-Education, Bay Harbour asked whether the Visitors Booklets were not already out of date, given the expected changes to the structure of Pathways.

Harry Fox, Area D5 Director raised a point of order, asking whether this question was a financial matter or a club growth matter.

DD Glen Pearce ruled that it was a club growth matter and should be raised under the club growth report.

There was no further discussion.

FM Sheryl Ryan moved that the Audited District Financial Statements for period 1 July 2022 to 30 June 2023 be adopted.

13.2 District Audit Committee Report

DD Glen Pearce asked IPDD Kathryn Duncan to present the Audit Committee report on behalf of Joy Ackrill, the District Audit Committee Chair.

IPDD Kathryn Duncan presented the report:

The District Audit Committee is responsible for reviewing and substantiating whether District funds have been spent in accordance with the mission and governing documents of Toastmasters.

The audit for the 12 months ended 30 June 2023 was completed in August 2023. The committee verified that all expense claims were appropriately approved with supporting documentation and is satisfied there was no unauthorised use of funds. The District financial reports accurately reflect District income and expenses.

The committee found some authorised expenses did not fully comply with Protocol 8.4: District Fiscal Management section 8. Other District Expenses. These expenses related to conferences and training. The total cost was \$1637.

These expenses were discussed with the District Director and explanations were provided. While each expense had been considered (and in one case the expense was seen as offsetting a saving), the District Audit Committee reminds District Executive Committee members of their obligations to appropriately manage expenses of this kind and comply with all Toastmasters International fiscal protocols.

Toastmasters WHQ Audit Committee Guidelines have been fully complied with for the year to 30 June 2023. An audit was not completed in line with NZ auditing standards as there is no requirement to do so.

I thank the District Audit Committee of Diane Stempa DTM PDD and Tania Sales DTM for their commitment to performing this audit during challenging times. I also thank District Finance Manager, Sheryl Ryan, for the way the financial records were presented. It helped the audit process immensely.

IPDD Kathryn Duncan moved that the report of the District 72 Audit Committee be received.

DD Glen Pearce opened the report for discussion.

Peter Simmonds, Area D4 Director asked what the \$1637 referred to in the Audit Committee report had been spent on.

Kath Cherrie, Area C6 Director raised a point of order pointing out that, as a member of the District Executive Committee, Peter Simmonds had the opportunity to raise this issue at the District Executive Committee meeting on Friday 15 September.

DD Glen Pearce ruled that Peter Simmonds could ask his question in his capacity as President of U-CAN-SPEAK.

IPDD Kathryn Duncan responded that the expenditure was in three categories:

- 1. Gifts given for judging in place of venue costs.
- 2. Gifts given at the Lower Hutt conference, which we recognise were excessive.
- 3. Costs for materials for training supplied by a partner company of the trainer, who is a Toastmaster. Kathryn mentioned that she felt the training was the best value training she had ever been to.

DD Glen Pearce: It has been moved that the District Audit Committee Report for the period 1 July 2022 to 30 June 2023 be received.

Voting via the electronic platform:

DD Glen Pearce thanked the Audit Committee for all their work.

13.3 District 72 Budget 2023-2024

The 2023-24 Budget is available on the website with brief comments on expenditure.

FM Sheryl Ryan presented the District 72 Budget for the period 1 July 2023 to 30 June 2024 and highlighted the following points:

- Toastmasters International Budget Limits: Toastmasters International limits the expenditure in particular categories to a fixed percentage of the total budget. In particular, the Travel category is limited to 25% of the total budget. This year our Travel expenditure is budgeted to be 34% of the total budget. Toastmasters International has approved an exception to the policy for District 72 this year. Marketing outside Toastmasters has a required minimum of 5% of total budget. We have budgeted a slightly higher figure of 7.5%. The conference budget nets to zero as required by policy.
- Revenue: Membership revenue has been set by Toastmasters International at \$60,443 up \$1,901 from 2022-23. Toastmasters International have been asked how they arrived at this number but are yet to reply. Conference Revenue is budgeted to be higher than last year.
- Expenditure: significant increases from last year include the conference expenditure, lodging and travel, significant decreases from last year include Education and Training and Recognition.

FM Sheryl Ryan moved that move that the District 72 Budget 2023-2024 be received. Seconded: Jacqui Blackwell, Division J Director

DD Glen Pearce opened the District 72 Budget 2023-24 for discussion.

Svetlana Sabitova, VP-Education, MBIE Toastmasters asked whether the reduction in the budget for Education & Training came from efficiency gains due to running training online or a reduction in the amount of training.

PQD Mary Jaksch responded that a lot of costs were associated with in-person training and now we can offer quality online training. The focus this year will be on offering low-cost, high-value training online.

Carol Mitchell, President, Cup Cake Communicators, asked why the budget for lodging was so high.

FM Sheryl Ryan explained that this was due to the high cost of accommodation for the Trio at the International Convention and training in the Bahamas, despite finding a cheaper alternative to staying in the Convention hotel.

Peter Simmonds, President, U-CAN-Speak, asked why the conference budget had nearly doubled when budgets for Division and Area contests were so restricted. He was concerned that the high cost of the conference would result in other costs being trimmed back.

FM Sheryl Ryan confirmed that the conference has to pay for itself so reducing the cost of the conference would have no effect on the amounts available for other areas. The costs are higher for the Dunedin conference, largely because the venue costs are higher.

There was no further discussion.

DD Glen Pearce opened all reports, other than the Finance Manager's reports, for discussion.

Area J2 Director Marty Pilott pointed out two corrections to the Division J Director's report. Firstly, he is from Newlands Club, not Newtown and the phrasing 'Each area has four or five functioning clubs with approximately 40 to 50 members each.' could be interpreted as 40 - 50 members per club.

Celina Templeman, VP-Education, Bay Harbour, asked about the new Visitors Booklet, which will already be out of date due to the changes to Pathways.

PQD Mary Jaksch responded that the Visitors Booklets focussed on the motivation to do Pathways, not the details, as they are given to visitors who will be deciding whether to join.

David Templeman, District Parliamentarian asked where are the booklets are.

PQD Mary Jaksch explained that many had already been sent to clubs that wanted them. Others were held by DD Glen Pearce.

DD Glen Pearce confirmed that he had brought some with him for district officers to take back to their clubs.

Area D5 Director Harry Fox asked if the stockpile of Visitor Booklets was recorded as an asset or were they expensed.

FM Sheryl Ryan confirmed that they were expensed and are not recorded as an asset.

There was no further discussion.

15 District Contest Format

DD Glen Pearce asked PQD Mary Jaksch to explain the background information from Toastmasters International, the decision to be made, and the recommendation of the District Executive Committee.

PQD Mary Jaksch explained that this meeting needs to decide whether Area, Division and District Contests should be held in hybrid format. The rationale for the hybrid format is that it is a more equitable solution as it means those who cannot travel or compete face-to-face for health or other reasons are still able to compete. The Board of Directors of Toastmasters International has made an exception to the Speech Contest Rule Book and has determined that all speech contests at the Area, Division and District levels may be conducted in-person only, online only or in hybrid format for the 2023-24 speech contest cycle. The recommendation of the District Executive Committee is that all Area, Division and District contests should be held in a hybrid format.

On behalf of the District Executive Committee, PQD Mary Jaksch moved that all 2023-2024 Area, Division and District speech contests be held in a hybrid format. Seconded: Area C3 Director Marie Fox

DD Glen Pearce opened the motion for discussion.

Karen Lynley, VP-Education, Toast NOW, asked if we were making a decision on this here without consultation with club members.

David Templeman, District Parliamentarian, explained that the information from the Board of Directors was that the District Executive Committee had to make a recommendation to the District Council, which has to make a decision. The Club Presidents and Vice-Presidents Education are part of the District Council.

DD Glen Pearce pointed out that all District Officers had received the email from the Board of Directors and the District had followed this up asking all Area Directors to follow-up with their clubs.

Karen Lynley commented that this did not happen in either of her clubs.

Madeleine Post, President, Dunedin Toastmasters, said that this had been discussed by the club committee and asked if there is a way to ensure that online contestants, some of whom may have poor internet connections, are judged fairly compared to in-person contestants.

PQD Mary Jaksch explained that there are guidelines for hybrid contests which include how to handle technical difficulties encountered while someone is competing. She pointed out that at International level the contests are hybrid. This decision will not affect club contests, which can continue to run face-to-face. The hybrid format makes it much easier for geographically challenged areas where clubs are far apart. There will be training on best practice in running hybrid contests.

Carol Mitchell, President, Cup Cake Communicators thanked the District Executive Committee on making an equitable recommendation but also said that her club had not heard from their Area Director.

Svetlana Sabitova, VP-Education, MBIE Toastmasters asked if there were different categories for people competing online and people competing face-to-face.

PQD Mary Jaksch responded that there is information on both the District 72 website and the Toastmasters International website on how to run hybrid contests.

Sheila Hailstone, President, Online Uncensored Comedians and Humourists, pointed out that some of their members are 12,000 miles away and cannot attend if contests are in-person. She thanked the District Executive Committee for their recommendation and commented that their club executive had voted on the proposal and their decision was to support the District continuing with hybrid contests at the area, division and district levels.

DD Glen Pearce: It has been moved and seconded that all 2023/2024 Area, Division and District speech contests, be held in a hybrid format.

Voting via the electronic platform.
